Currently, 47.2% of the 65,141 housing units in the area are owner occupied; 43.4%, renter occupied; and 9.4% are vacant. Currently, in the U.S., 55.7% of the housing units in the area are owner occupied; 32.8% are renter occupied; and 11.6% are vacant. In 2010, there were 63,513 housing units in the area - 49.0% owner occupied, 41.9% renter occupied, and 9.1% vacant. The annual rate of change in housing units since 2010 is 1.13%. Median home value in the area is \$130,025, compared to a median home value of \$200,006 for the U.S. In five years, median value is projected to change by 4.62% annually to \$162,998.
